As established by art. 32 of EU Regulation 679/2016, the Owner implements appropriate technical and organizational measures to ensure a level of security appropriate to the risk of processing.

**DATA RETENTION PERIOD**

The personal data provided by you are stored for the entire duration of the contractual relationship as well as for the legal storage period.

**RECIPIENTS OF THE DATA**

The data are also processed by the staff of Weiss Technik Italia S.r.l. by virtue of specific instructions provided regarding the purposes and methods of processing.
